

Japan Climate Action Summit Declaration

We, the undersigned below, gather together forces of non-state actors such as cities, municipalities, companies and other types of organizations pledge to accelerate and to lead the decarbonization of Japan and the world in order to achieve the purpose of the Paris Agreement, which is “holding the increase in the global average temperature to well below 2°C above pre-industrial levels and pursuing efforts to limit the temperature increase to 1.5°C above pre-industrial levels.”

The extreme weather events such as extremely high temperatures, typhoons, heavy rainfalls and floods, which caused the devastating damages across Japan during the summer in 2018, reinforced the fact that Japan is also very vulnerable in the face of climate impacts. The IPCC Special Report on Global Warming of 1.5 C released on October 8th again reemphasized the tremendous magnitude of climate impacts in the world and the urgency of action.

In the meantime, the transition to a decarbonized society creates opportunities for further growth and development. Also, these efforts in support of decarbonization share the same aims as the Sustainable Development Goals (SDGs) adopted by the United Nations in 2015.

Under such circumstances, national governments around the world will come to COP24 in December, 2018 to discuss finalization of the “rulebook” to implement the Paris Agreement. Talanoa Dialogue for enhancing climate targets will also be held. We expect world leaders to send clear messages so that COP24 outcome enhances decarbonization action by governments and non-state actors.

Japan Climate Initiative (JCI) is steadily gaining members since its launch on July 6th, 2018. The number of member organizations has now surpassed 270 after the mere three months since its inception. We will invite more organizations to join us further, will enhance collaboration among members and will engage with others to make the decarbonization trend consensus of the Japanese society as a whole.

In September, JCI participated in the Global Climate Action Summit organized by the State of California in the United States and presented Japanese climate action to the international community, which was well received with support. JCI will continue international communication and collaboration such as this further in the future.

Japan holds presidency of the upcoming G20 in June, 2019. The Government of Japan has started a process to develop its long-term low emission development strategy to be presented before G20. We will conduct dialogue with the government so that the long-term strategy should include elements to show a clear direction of decarbonization in which Japanese leadership can accelerate the world’s efforts through enhancement of Japanese climate action with focus on renewable energy and energy efficiency.

We will make Japan an epi-center of a global decarbonization trend.
