

Japan needs an ambitious long-term strategy to show Japan's decarbonization leadership to the world

*Statement of the Japan Climate Initiative in response to the Japanese Government's draft
long-term strategy*

As the Paris Agreement moves to the implementation stage, Japan must accelerate its efforts towards decarbonization.

Given that Japan holds this year's G20 Presidency, 2019 will be a great opportunity for Japan to show the international community its leadership when it comes to decarbonization. The Japanese government is preparing its long-term strategy based on the proposal developed by a special advisory council known as "Meeting for the Long-Term Strategy under the Paris Agreement as A Growth Strategy." The proposal was published on April 2nd as part of a process¹ that will culminate with the presentation of Japan's strategy by the G20 Osaka 2019 Summit.

Last October, the 1.5 °C Special Report published by the Intergovernmental Panel on Climate Change (IPCC) showed that the world needs to reach "net zero" by 2050 and reduce CO₂ emissions by about 45% by 2030 relative to 2010 levels in order to keep the global temperature rise below 1.5 °C. The proposal of "Long-Term Strategy under the Paris Agreement as A Growth Strategy" recognized that the urgency and the need to enhance climate actions highlighted in the report were widely accepted by the international community. The proposal also asked the Japanese government to set the future vision of the decarbonized society as a final target and to aim to achieve it as early as possible in the second half of this century.

In the Japanese context, the most important set of measures to realize a decarbonized society is to promote energy efficiency in a comprehensive manner and maximize the use of renewable energy. In Japan, in particular, the renewable energy target of the Japanese government should be further raised as it is the key to significantly reduce reliance on fossil fuels such as coal in the years ahead.

¹ The national government-led process included: (a) the establishment of a special advisory council known as "Meeting for the Long-term Strategy under the Paris Agreement as a Growth Strategy;" (b) the development of a series of recommendations by the advisory council which are meant to serve as the basis for the national government's long-term strategy (LTS) draft, published on April 2; (c) the publication of the draft LTS on April 23; (d) about 3 weeks public comment period which ended on May 16; and (e) the incorporation of public comments; and (f) the publication of the final version of the LTS, expected right before the G20 meetings in Osaka, Japan, in June.

Amid the world's accelerating decarbonization trend, many companies and local governments in Japan are starting to work beyond the conventional government plans to achieve greater use of renewable energy and zero emissions. The long-term strategy developed by the government must support such pioneering efforts by Japanese actors to accelerate their efforts and contribute to building the decarbonized society that we need in Japan.

If the government issues a clear message for decarbonization, it will further accelerate the leading efforts by private sectors and local governments, and contribute to making Japan an advanced country when it comes to the business of decarbonization.

As a member of the Japan Climate Initiative that promised to stand at the frontline of the climate challenge along with the world to realize the decarbonized society demanded by the Paris Agreement, we strongly ask for a more ambitious long term strategy that shows Japan's leadership to the world when it comes to addressing climate change.
